MINUTES August 12, 2021

The Somerset Township Board of Supervisors met in Regular Session on Thursday, August 12, 2021, at 6:30 pm in the Somerset Township Municipal Building. Those present were: Daniel H. Halverson, Chairman; Donald K. Miller, Vice-Chairman, and Randy Beistel, Supervisor as well as Tami L. Yutzy, Secretary and Michael P. Barbera, Solicitor.

The Chairman, Mr. Halverson, called the meeting to order and lead the pledge to the flag.

Mr. Halverson then asked for any public comment. There was none.

The Chairman asked for the reading of the Minutes of the previous meeting and the Financial Report for the previous month. Mrs. Yutzy presented the board with the Minutes of the previous meeting and the July List of Expenditures. Mr. Beistel moved to approve all as presented. Mr. Miller seconded the motion. With all voting "yea" the motion carried and all stand approved as presented.

The next item on the agenda was to award the 2021-2 Paving Project—consisting of road paving of Walter's Mill RD (T-519). Somerset Township received bids from New Enterprise Stone & Lime Co., Inc., Quaker Sales, Corp., CH&D Ent. Inc., and HRI, Inc. The bids were then opened by the Secretary. Mrs. Yutzy read the first bid from New Enterprise Stone & Lime Co., Inc. for \$47,993.30, the second bid Quaker Sales Corp. for \$49,664.00, the third bid CH&D Ent., Inc. for \$89,652.40, and the fourth and final bid from HRI, Inc. for \$56,487.00. Mr. Halverson called for a motion to award the Paving bid of \$47,993.30 to New Enterprise Stone & Lime Co., Inc. Mr. Miller made the motion to accept the bid from New Enterprise Stone & Lime Co., Inc. and Mr. Beistel seconded it. With all voting Yea the motion carried and the 2021-2 paving bid stands awarded. The Board then discussed that the November 11, 2021 meeting is scheduled for the Veteran's Day Holiday. It was determined to reschedule the November meeting for November 19, 2021 at 3:30 p.m. Mrs. Yutzy stated that she would advertise the meeting change in the Daily American.

The Chairman then ask solicitor, Michael Barbera, if he had anything to report. Mr. Barbera stated he had nothing to report to the board at this time.

The Chairman then called for any additional business before the Board. There was none. With no other business before the Board, Mr. Halverson declared the meeting adjourned. There were no objections.
